~~EMERGENCY ORDINANCE~~

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

SECTION 1. That Chapter 59, Section 5150 of The Oklahoma City Municipal Code, 2020, be amended to change the boundaries of the C-3 Community Commercial District, as shown upon the District Map to include therein the following described property:

A tract of land being a part of the Northwest Quarter (NW/4) of Section Thirty-Three (33), Township Fourteen (14) North, Range Three (3) West of the Indian Meridian, Oklahoma County, Oklahoma and being more particularly described as follows: BEGINNING at the Northwest corner of said Northwest Quarter (NW/4); THENCE South 89°38'20" East, along the North line of said Northwest Quarter (NW/4), a distance of 660.00 feet; THENCE South 00°21'40" West, a distance of 662.25 feet; THENCE North 89°38'20" West, and parallel to the North line of said Northwest Quarter (NW/4), a distance of 655.83 feet to a point on the West line of said Northwest Quarter (NW/4); THENCE North 00°00'00" West, along said West line, a distance of 662.26 feet to the POINT OF BEGINNING.

~~SECTION 2 (EMERGENCY) WHEREAS, it being immediately necessary for the preservation of the peace, health, safety, and public good of Oklahoma City and the inhabitants thereof that the provisions of the ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this ordinance shall take effect, and be in full force from and after its passage as provided by law.~~


