Concurrence with the Oklahoma City Water Utilities Trust in approving Change Order No. 2 with Archer Western Construction, LLC, Project WT-0201, Hefner Water Treatment Plant Lime System Improvements, increase of \$880,218.94. Ward 8.

**Location:**

Hefner Water Treatment Plant

**Justification:**

It is necessary to add items to match the scope of the project.

**Background:**

This project replaces the existing lime storage and feed equipment with a new reliable, flexible, and readily expandable lime storage and feed system.

Change Order No. 2 adds pay items due to modifications of the lime feeder and lime mixer, as well as the electrical improvements that include Heat Trace for system protection and more lighting for safety. The demolition of the current lime building will be completed by the current contractor. This change order adds the labor to demolish a sedimentation basin, place the demolished lime building materials into the basin pit, and the dirt and labor to backfill over the materials. Utilizing the contractor currently on site will eliminate future costs for mobilization and equipment, and placing the crushed building materials and concrete in the basin will reduce the volume of dirt required to fill the basin pit; an estimated savings of \$1,500,000.

Change Order No. 2 is an increase of \$880,218.94 or 3.27 percent above the original contract amount. Change Order Nos. 1 and 2 represent an increase of \$1,100,759.01 or 4.09 percent above the original contract amount. Amendment No. 1 represent a decrease of \$348,057.75. The revised contract amount is \$27,661,801.26.
