SUBJECT: Sole Source – Axon Enterprises (Evidence Data Management System)

The department has a continued need for this sole source contract to be renewed. Council approved the Master Services and Purchasing Agreement with Axon Enterprise 9/14/21 IX BW. Since its inception, Axon has provided the hardware and software used to record, store, audit and distribute interviews by investigators for the Oklahoma City Police Department. However, there are some software licenses that are not included with the agreement. There also may be the need to purchase additional equipment and hardware that are not covered by the Master Services and Purchasing Agreement with Axon Enterprise contract.

Estimated cost: \$300,000.00


