Ratifying and approving Addenda Nos. 1, 2 and 3; adopting resolution extending time to award contract and awarding contract to TLS Group, Inc., Projects TC-0631 and TC-0633, Intersection Improvements, NW 150th Street at Lone Oak Drive and North May Avenue at NW 192nd Street, \$1,083,750.20; assigning Professional Service Industries, Inc. as the testing laboratory; and approving contract and bonds. Ward 8.

TC-0631 NW 150th Street and Lone Oak Drive
TC-0633 North May Avenue and NW 192nd Street

Background:

This American Rescue Plan Act (ARPA) and Streets Development Impact fees project provides for Traffic Signalization, ADA compliant upgrades of ramps, crosswalks, landings and pushbutton access for pedestrian traffic at all four crossings of the intersections.

The project was advertised, and bids were received from prospective bidders. Addenda were required to address plan resolution quality, detail clarifications and quantity revisions.

Provisions of the Public Competitive Bidding Act of 1974, provide for a public improvement construction contract be awarded within 30 days or within 45 days for good cause shown or within 120 days upon mutual agreement between the lowest responsible bidder and the awarding public agency

Due to bid evaluation and time needed to receive executed contract and bonds, contract award was delayed, preventing award within 30 days of receipt of bids. A letter agreeing to honor the bid for 45 days has been received from the lowest responsible bidder.

Construction is scheduled to begin late fall 2024 and be completed in Summer 2025.
