

**RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST EXTENDING TIME TO AWARD CONTRACT AS MUTUALLY AGREED, AWARDING CONTRACT TO C-P INTEGRATED SERVICES, PROJECT WM-0393, LAKE HEFNER DRIVE RETAINING WALL REHABILITATION, SOUTH LAKE HEFNER DRIVE AND NORTH PORTLAND AVENUE, \$568,321.25; AND APPROVING THE CONTRACT AND BONDS.**

**WHEREAS**, Project WM-0393 replaces a stone basket retaining wall that is failing due to soil erosion occurring between the baskets and the storm drainage pipe; and

**WHEREAS**, the failing section will be replaced with a cast-in-place wall; and

**WHEREAS**, the Oklahoma City Water Utilities Trust (OCWUT) has advertised and received bids for Project WM-0393; and

**WHEREAS**, the Public Competitive Bidding Act of 1974 states that a contract for construction of a public improvement must be awarded within 30 days or within 45 days for good cause shown or within 120 days upon mutual agreement between the lowest responsible bidder and the awarding public agency or agencies; and

**WHEREAS**, it is the desire of OCWUT to award the contract to the lowest and best responsible bidder; and

**WHEREAS**, the bids were opened on February 21, 2024; and

**WHEREAS**, this contract was delayed due to necessary review period requirements and the meeting schedule of the Oklahoma City Water Utilities Trust; therefore, preventing award within 30 days of receipt of bids; and

**WHEREAS**, a letter agreeing to honor the bid for 45 days has been received from Contractor.

**NOW, THEREFORE, BE IT RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby extend time to award this contract as mutually agreed, award contract to C-P Integrated Services, Project WM-0393, Lake Hefner Drive Retaining Wall Rehabilitation, South Lake Hefner Drive and North Portland Avenue, \$568,321.25; and approve the contract and bonds.
