## The City of OKLAHOMA CITY

TO: Chairman and Trustees of the Oklahoma City Municipal Facilities Authority

1. Joint Resolution with The City of Oklahoma City authorizing the firm Collins, Zorn, & Wagner, P.C. to represent City employees Jose Colmenares and Eldon Walsh in the case of *Kevin Dickerson v. Officer Jose Colmenares and Officer Eldon Walsh*, United States District Court, Western District of Oklahoma, Case No.CIV-24-554-G;

AND/OR

2. Enter into Executive Session on advice of the Municipal Counselor to receive confidential communications from its attorney concerning the above pending litigation, as authorized by 25 O.S. (2023 Supp.) §307(B)(4), because disclosure would seriously impair the ability of the public body to process the claim or conduct a pending investigation, litigation or proceeding in the public interest.

On June 4, 2024, Plaintiff filed his Pro Se Complaint for a Civil Case in the United States District Court for the Western District of Oklahoma against Oklahoma City Police Department employees Officer Jose Colmenares and Sgt. Eldon Walsh. This pro se Complaint alleges 42 U.S.C. §1983 Civil Rights violations, as well as Fourth Amendment unreasonable search and seizure, assault and battery, false arrest, defamation, slander and libel, and “failure to respect request for higher authority”, for an incident alleged to have occurred on July 22, 2023.

This lawsuit concerns an incident on July 22, 2023, when OCPD Officer Colmenares was assisting Oklahoma County Deputy Johnson on a traffic stop. A strong odor of marijuana was coming from the vehicle, the driver was non-compliant by refusing to exit the vehicle, and was on the cell phone with someone during this traffic stop. OCPD Sgt. Eldon Walsh and his K9 responded to the scene. The driver was taken into custody, whereupon Kevin Dickerson arrived and began interfering with the officers, by refusing to follow their commands, demanding to speak to a captain, and advancing on Sgt. Walsh and his K9. Kevin Dickerson was briefly taken into custody and was issued a municipal citation for Interference with Official Process by obstruction. The initial driver on the traffic stop was Kevin Dickerson’s adult son.

Oklahoma City employees Officer Jose Colmenares and Sgt. Eldon Walsh have requested that the firm of Collins, Zorn & Wagner, P.C. represent and defend them in this lawsuit. The facts and documents available at this time indicate both employees were acting in good faith and within the course and scope of their employment during all times of the events set forth in the above-styled lawsuit. It is the recommendation of this office that outside counsel be retained to represent the municipal employees and that this representation be at the expense of the City so long as such

representation seems appropriate to the Mayor and Council subject to the requirements of 51 Okla. Stat. §151, *et seq.*, 11 Okla. Stat. §23-101, *et seq.*, and the applicable case law, because there is a potential of a conflict of interest between the City and its employees if the Plaintiff's allegations are true.

Title 51 Section 162 of the Oklahoma Statutes requires:

A. [A]ny political subdivision, subject to the procedure requirements imposed by this section, other applicable statute, ordinance, resolution or written policy, shall:

1. Provide a defense for any employee . . . when liability is sought for any violation of property rights or any rights, privileges or immunities secured by the constitution or laws of the United States when alleged to have been committed by the employee while acting within the scope of employment;

Title 11, Section 23-101 states:

...if an action is brought against a municipal employee in any civil action or special proceeding in the courts of this state or of the United States by reason of any act done or omitted in good faith in the course of employment, the governing body of the municipality shall direct the municipal attorney or other designated legal counsel to appear and defend the action or proceeding on the behalf of the employee in accordance with the provisions of Section 11-23-102 of this title.

Further, Article 26 of the Collective Bargaining Agreement between the Oklahoma City Police Department and the Fraternal Order of Police, Lodge 123 states:

All police officers who are sued for violation of constitutional rights while acting in the capacity of a police officer in which they are individually named as Defendants and punitive damages are sought shall have the right to representation by outside counsel. The officer shall be represented by private counsel who is approved by FOP Lodge 123 and the City Council as having expertise in the defense of police officers in civil rights actions. The City agrees to pay the reasonable fees and costs for said services as set forth in the contract between the City and outside counsel and pursuant to 11 O.S § 23-101.

It is the recommendation of this office that outside counsel be retained to represent employees Officer Jose Colmenares and Sgt. Eldon Walsh, and that this representation be at the expense of the City subject to the requirements of 51 Okla. Stat. §151, *et seq.*, 11 Okla. Stat. §23-101, *et seq.*, and applicable case law. If additional discussion is necessary, it is the recommendation of the Municipal Counselor that the Mayor and Council enter executive session to discuss the ongoing litigation.
