Final Acceptance with Central Oklahoma Transportation and Parking Authority and Oklahoma City Water Utilities Trust, Projects MC-0619, MS-0123, and WC-1029, Northwest Bus Rapid Transit, Transit Center Downtown at North Broadway Avenue and West Main Street, providing service north on North Classen Boulevard to North Meridian Avenue and NW Expressway; and placing maintenance bond into effect. Wards 1, 2 and 6.

**Location:**

Transit Center Downtown at North Broadway Avenue and West Main Street, along North Classen Boulevard to North Meridian Avenue and NW Expressway

**Background:**

This 2017 General Obligation Bond and Federal 2018 BUILD Discretionary Grant project provided for construction of the Northwest Bus Rapid Transit System. This project included bus pads and stations, sidewalk, bike lanes, lighting, ADA improvements, pedestrian crossings, traffic signal modifications and procurement of new vehicles.

This contract was awarded on May 24, 2022, and was substantially complete on October 4, 2023. This project took additional time to final accept due to material delays for items on the punch list.

Travelers Casualty and Surety Company is the surety company for the two (2) year Maintenance Bond, Bond No. 107614264.

The City and the Oklahoma City Water Utilities Trust (OCWUT) have received the necessary easements, as-built drawings, and the maintenance bond for this project. After dedication to and acceptance of this project by the City and OCWUT, the water and sanitary mains included in the project, excluding any private service lines, will become the property of the City. After acceptance of the project and expiration of the maintenance bond, the City, through the Utilities Department will be responsible for future maintenance of the City-owned water and sanitary sewer mains.
