The City of Oklahoma City and Eide Bailly, LLP, have the option of renewing the 2022-2023 Professional Services Agreement to provide financial and administrative services related to the Coronavirus State and Local Fiscal Recovery Funds and the Emergency Rental Assistance Program Funds. The renewal shall be subject to the same terms, conditions and provisions as entered into by the parties on February 1, 2022. This renewal contract shall be retroactive from February 1, 2025 with a term ending on January 31, 2026. It should be noted that the February 1, 2022 Agreement entered into between the parties was a pricing agreement authorizing the City to pay a not-to-exceed amount of \$46,000 over the one-year term and including four possible renewals. To date, Eide Bailly has invoiced the City \$6,333.75, leaving \$39,666.25 available on the contract over the next two years.
