Joint Resolution with the Oklahoma City Municipal Facilities Authority authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2022-05728H styled: *Bryan Gil, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, Bryan Gil is 27 years old and a 5-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Police Department as a Police Officer and continues to be employed by the City.

The Claimant sustained an undisputed accidental injury on July 10, 2022 to his left ankle. The Claimant required surgery to his left ankle on July 14, 2022 and June 27, 2024.

The Claimant was evaluated by Dr. Lance Rosson on behalf of his attorney and found to have the following permanent partial impairment: left ankle 44%. The Claimant was also evaluated by Dr. Calvin Johnson on behalf of the City and found to have the following permanent partial impairment: left ankle 13%. The negotiated Joint Petition Settlement calls for a PPD award of \$15,840 for the following permanent partial disability: left ankle 20%.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$475.20 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award \$15,364.80. The settlement further calls for \$3,168 to be deducted from the PPD award and paid in a lump sum to Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$118.80 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$316.80.
