Concurrence with the Oklahoma City Water Utilities Trust in approving Change Order No. 2 with Wynn Construction Company, Inc., Project ST-0149, North Canadian Wastewater Treatment Plant Improvements and Upgrades, increase of \$814,799.27. Ward 7.

**Location:**

North Canadian Wastewater Treatment Plant

**Purpose:**

To add pay items to match the field conditions and add contract time.

**Justification:**

To adjust the plan quantities to match the actual quantities for completion of the project.

**Background:**

This project will improve and make necessary repairs to the North Canadian Wastewater Treatment Plant for equipment that has reached the end of its useful life.

Change Order No. 2 adds four new pay items to the contract. Pay Item No. 2.1 adds the cost due to the demolition of existing cable trenches and surface restoration that was mistakenly left off the bidding form. Pay Item No. 2.2 adds the cost related to the pumping required to drain and isolate each of the four primary clarifiers in preparation for rehabilitation. All four clarifiers must be partially emptied each time the plugs are installed and removed. Pay Item No. 2.3 adds the cost of utilizing a different material for grating anchors, as recommended by the manufacturer. Pay Item No. 2.4 adds an allowance for costs related to investigating the condition of the existing drainage structures related to primary clarifiers No. 5, 6, 7, and 8. Investigation methods may include televising the drain pipelines, investigating the operation of the isolation plug valves, and investigating the condition of the existing fittings and connections. An additional 46 calendar days are added for the delays due to the changed order items.

Change Order No. 2 is an increase of \$814,799.27 or 1.45 percent above the original contract amount. Change Order Nos. 1 through 2 represent a decrease of \$2,142,225.73 or 3.80 percent below the original contract amount. The revised contract amount is \$54,175,619.27.
