

RESOLUTION

RESOLUTION AUTHORIZING THE ACCEPTANCE OF \$60,158 GRANT FROM THE OKLAHOMA HIGHWAY SAFETY OFFICE; RATIFYING SUBMITTAL OF THE INTERNET BASED APPLICATION BY THE CHIEF OF POLICE AND THE POLICE DEPARTMENT BUSINESS MANAGER, AUTHORIZING THE MAYOR TO SIGN ANY NECESSARY DOCUMENTS; AUTHORIZING THE POLICE BUSINESS MANAGER OR MANAGEMENT SPECIALIST TO SUBMIT THE INTERNET ACCEPTANCE, REQUESTS FOR FUNDS, PROVIDE REPORTS AS REQUIRED, AND TO ADMINISTER THE GRANT; AND AUTHORIZING THE CITY TREASURER TO RECEIVE AND DEPOSIT THE FUNDS IN THE GRANTS MANAGEMENT FUND.

WHEREAS, this grant provides funding for the Oklahoma City Motorcycle Safety Program as directed by the Oklahoma Highway Safety Office (OHSO); and

WHEREAS, the grant period is October 1, 2023 through September 30, 2024; and

WHEREAS, this will be the first year of funding for this program; and

WHEREAS, the grant provides overtime funding for officers and supervisors to work Motorcycle Safety shifts on weekends, holidays and any other days approved by OSHO. Funding is also being provided for the purchase of equipment including an enclosed cargo trailer and safety cones; and

WHEREAS, no City match is required for this grant; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Oklahoma City that the City is authorized to accept the award for the 2024 Oklahoma Highway Safety Office Grant of \$60,158.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the submittal of the internet-based application by the City Manager and the Police Department Business Manager is ratified.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the Mayor is authorized to sign any necessary documents.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the Police Business Manager or Management Specialist are authorized to submit the internet acceptance, requests for funds, provide reports as required, and administer the grant and the City Treasurer is authorized to receive and deposit these funds into Grants Management Fund 019.
