Joint Resolution with The City of Oklahoma City authorizing the Risk Manager and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2021-03229J styled: *Ryan Williams, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Ryan Williams is 50 years old and a 26-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Fire Department as a Corporal and retired from the City as of July 1, 2021.

Claimant sustained an undisputed accidental injury on September 3, 2020 to his lungs and heart.

Claimant was evaluated by Dr. Lonnie Litchfield on behalf of his attorney and found to have the following permanent partial impairment: lungs 20%, heart 6%. The Claimant was also evaluated by Dr. William D. Jones on behalf of the City and found to have the following permanent partial impairment: lungs 6%, heart 4%.

The negotiated Joint Petition Settlement calls for a lump sum of \$23,940 for the following permanent partial disability: lungs 10%, heart 9%. The settlement includes an additional payment of \$740, for a total award of \$24,680.

The settlement further calls for a 3% assessment of the PPD award, less the additional payment amount, in the sum of \$718.20 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award, including the payment, \$23,961.80. The settlement further calls for \$4,936 to be deducted from the PPD award and paid in a lump sum to the Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs of \$140; a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$185.10; and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$478.80.
