JOURNAL ENTRY OF JUDGMENT

This cause comes on for consideration on this date, the Plaintiff, Vanessa House Beer Co., L.L.C., appearing through its attorneys, James Johnson and Russell Wantland of Resolution Legal Group, and the Defendant and Third-Party Plaintiff, The City of Oklahoma City, a municipal corporation, appearing by Dustin W. Parris and Steven A. Barker, Assistant Municipal Counselors, counsel for Defendant and Third-Party City. The Court finds that the City Council of The City of Oklahoma City has approved the recommendation of the Municipal Counselor to confess judgment without admission of liability in the case herein in the amount of Sixty Thousand and 00/100 Dollars (\$60,000.00) as evidenced by a certified copy of the attached Resolution. This sum includes all claims for prejudgment interest. Parties agree to bear their respective court costs and

attorney fees. This is a compromise settlement of a disputed claim and is in no way an admission of liability.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that pursuant to a compromise settlement of a disputed claim, and without admission of liability, the Plaintiff is granted judgment against the Defendant and Third-Party Plaintiff, The City of Oklahoma City, in the sum of (\$60,000.00) with interest from the date of filing of this Judgment at the rate of 5.09% per annum and if not paid in full by December 31, 2024, at a rate of interest to be calculated annually in accordance with 12 Okla. Stat. §727.1. Said sum shall be paid in accordance with 62 Okla. Stat. §§365.5 and 365.6, and 51 Okla. Stat. §§158 and 159.
