 Project No. PC-0698/WC-1026  
 Roadway Widening, SW 149<sup>th</sup> Street between Western Avenue and Santa Fe Avenue, Ward 5

Honorable Mayor and Council:

**I. SCOPE**

Amendment No. 1 adjusts plan quantities to match quantities in the field necessary for the completion of the project. Change Order No. 1 adds new pay items to the contract.

**II. JUSTIFICATION**

Changes in estimated quantities to complete the project. Amendment No. 1 removes the relocation of waterline Line C and Line D and adds two blow off valves for testing.

Change Order No. 1 adds a pay item for waterline Line E to add two tapping valves and sleeve connections in lieu of wet connections to provide customers with water service; includes night work to cut and cap the line and additional rock backfill. Change Order No. 1 also includes two school zone signs; 1100 feet of 6' tall chain link fence (11-month rental); and to set and remove 1100 feet of 4' tall orange safety fence to provide access to the school.

Amendment No. 1 is a decrease of \$121,550.00 or 2.52 percent below the original contract amount. Change Order No. 1 is an increase of \$43,857.62 or 0.91 percent above the original contract amount. Amendment No. 1 and Change Order No. 1 result in an overall decrease of \$77,692.38. The revised contract amount is \$4,749,791.37.


