Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2023-0020812 styled: *John Ricketts, Claimant vs. The City of Oklahoma City*, Respondent, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, John Ricketts is 57 years old and a 29-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Police Department as a Sergeant and continues to be employed by the City.

Claimant was evaluated by Dr. William D. Jones, on behalf of the City and found to have the following permanent partial impairment: both ears 13%. The negotiated Joint Petition Settlement calls for a PPD award of \$15,444 for the following permanent partial disability: both ears 13%. The settlement includes a payment of \$500, for additional consideration for a total award of \$15,944.

The settlement further calls for a 3% assessment of the PPD award, less the additional payment amount, in the sum of \$463.32 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award, including the additional payment, \$15,480.68. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$119.58 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$308.88.
