In light of what Lamar Advertising was informed by Councilmembers Stonecipher and Nice at the City Council meeting held on Tuesday, April 9th during the final hearing for PUD-1949, please let this email service as Lamar Advertising's intent to formally protest SPUD-1613. We were informed by council in the meeting that the city will no longer allow this type of off-premise signage within a SPUD rezoning.
