Honorable Chairman and Trustees:

I. **SCOPE**

Amendment No. 1 is the final amendment to reconcile all the quantities installed in the field.

II. **JUSTIFICATION**

Amendment No. 1 reconciles all differences between the estimated and actual quantities used during the construction of this project. An additional 11.67 square yards of sidewalk (concrete) and an additional 240 square yards of solid slab sodding was due to excavation and safe shoring during the construction.


