Joint Resolution with the Oklahoma City Municipal Facilities Authority authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2022-02437Q styled: *Scott Landis, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Scott Landis is 53 years old and a 24-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Fire Department as a Lieutenant and retired from the City as of January 1, 2023.

The Claimant sustained an undisputed accidental injury on August 5, 2021 to his left knee. The Claimant required surgery to his left knee on January 11, 2022 and April 3, 2023.

The Claimant was evaluated by Dr. Lance E. Rosson on behalf of his attorney and found to have the following permanent partial impairment: left knee 55 %. The Claimant was also evaluated by Dr. William D. Jones, on behalf of the City and found to have the following permanent partial impairment: left knee 16%. The negotiated Joint Petition Settlement calls for a PPD award of \$32,670 for the following permanent partial disability: left knee 33%. The settlement includes an additional payment of \$302.40, for additional consideration for a total award of \$32,972.40.

The settlement further calls for a 3% assessment of the PPD award, less the additional payment, in the sum of \$980.10 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award, including the additional payment, \$31,992.30. The settlement further calls for \$6,594.48 to be deducted from the PPD award and paid in a lump sum to Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$247.29 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$653.40.
