FY2021 – FY2022 Membership Dues

In 2017 the National League of Cities Board of Directors adopted a policy to implement an annual dues adjustment based on the Consumer Price Index (CPI). The maximum dues adjustment is capped at three percent (3%), regardless of CPI. Current NLC dues population categories are based on the most recent decennial U.S. Census (2010).
