Unfortunately, beyond Oklahoma Cement Solutions control, the manufacture of our Portland cement, Buzzi Unicem, is raising our cement price by \$12.00 per ton starting January 1<sup>st</sup>, 2024. The cement is used to produce cement slurry for soil stabilization. With this being a significant increase in the production of cement slurry, OCS is requesting an increase to the contractual price for cement slurry by \$12.00 per ton. Starting January 1<sup>st</sup>, 2024, the new price will be \$280 per ton. Attached is a letter from Buzzi notifying OCS of their increase.
