Mr. Gravlin:

Please find enclosed Amendment No. 2. This modification reconciles the final quantities of the project that has been fully completed.

We have reviewed the final quantities of the project provided by the contractor and find them to be accurate. The amendment results in an additional \$200,350.06 based on final installed quantities.

The original bid documents included a base bid for asphalt which only included 115 LF of curb & gutter. However, the optional bid for concrete (which was awarded) included replacement of all the curb & gutter which was 8,650 LF of removal and placement of 6” integral curb. This appears to be the primary miss in the original quantities since the subgrade and aggregate base quantities, within the design plans, were shown as equal in both the base and alternate bid. The Concrete placement area quantity was shown as the same as the asphalt quantity in the base bid but should have extended to the back of curb. Subgrade and aggregate base quantities should have extended 10 inches beyond the back of curb in the alternate bid concrete option. Below is a comparison table of the items these primary items
