Dear Mark Keesee:

As you know Genuine Parts Company d/b/a NAPA Auto Parts (“NAPA”) operates an onsite store and provides vendor managed inventory and related services to the Oklahoma City Water Utilities Trust (“OCWUT”). We are writing to request your consent to increase the fixed monthly administration fees payable in connection with NAPA servicing the onsite store for OCWUT to \$20,000. While the parties’ agreement permits annual CPI adjustments without formal action, the parties believe that it is in the best interests of both parties to add an additional NAPA employee to the onsite store, which will result in increased costs to NAPA. In the interests of maintaining a strong relationship, we wanted to seek your agreement to the increased fees before NAPA adds the additional employee.

NAPA believes that OCWUT’s agreement to the requested increase will enable NAPA to attract a strong candidate to the contemplated position.
