Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2023-03702A styled: *Kevin Wallace, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, Kevin Wallace is 61 years old and a 24-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Fire Department as a Corporal and retired from the City as of December 19, 2023.

The Claimant sustained an undisputed accidental injury on December 16, 2022 to his right knee. The Claimant required surgery to his right knee on April 24, 2023.

The Claimant was evaluated by Dr. Lance E. Rosson on behalf of his attorney and found to have the following permanent partial impairment: right knee 55%. The Claimant was also evaluated by Dr. William D. Jones on behalf of the City and found to have the following permanent partial impairment: right knee 25%. The negotiated Joint Petition Settlement calls for a PPD award of \$34,650 for the following permanent partial disability: right knee 35%. The settlement includes a payment of \$350, for additional consideration for a total award of \$35,000.

The settlement further calls for a 3% assessment of the PPD award, less the payment of the additional payment amount, in the sum of \$1,039.50 be deducted and paid on behalf of the claimant for the Multiple Injury Trust Fund Tax, making the lump sum award, including the additional payment, \$33,960.50. The settlement further calls for \$7,000 to be deducted from the PPD award, including the additional payment, and paid in a lump sum to the Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$262.50 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$693.
