

**RESOLUTION**

A RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY ESTABLISHING A DATE FOR THE PROPOSED ENACTMENT OF AN ORDINANCE CLOSING A PUBLIC WAY OR EASEMENT, DETERMINING THOSE ENTITLED TO NOTICE OF SAME, AND DIRECTING THAT SAID NOTICE BE ISSUED.

WHEREAS, an application to close the following described public way or easement has been considered by the Planning Commission of The City of Oklahoma City as part of a Master Plan or amendment of same, to-wit:

A tract of land being a part of the Southeast Quarter (SE/4) of Section Twenty-Eight (28), Township Twelve (12) North, Range Three (3) West of the Indian Meridian, Oklahoma City, Oklahoma County, Oklahoma, and being a portion of SCOTTS ADDITION according to the Plat recorded in Book PL1, Page 47, being more particularly described as follows: All of the Westerly North-South Alley in said SCOTTS ADDITION from the South Right-of-Way line of N.W. 14th Street to the extended Centerline of the East-West Alley in said SCOTTS ADDITION.

WHEREAS, an ordinance closing the same is proposed to be considered by the City Council on the 12TH day of MARCH, 2024; and
