

1. **Check-in time is 3 p.m. CST and check-out time is 11 a.m. CST.** For any special requests or accommodations, please be in communication with your host so that we may coordinate with our cleaning staff.
2. Guests and visitors should comply with the parking regulations and requirements and must show consideration to other vehicles in the neighborhood. Please note there is no on-street parking allowed on the South side of the street.
3. A maximum of 3 vehicles may park in the driveway, with a maximum of 1 vehicle being parked in the garage..
4. **No smoking of any kind inside the Airbnb.** Cigarette butts must be disposed of in the ashtray provided in the backyard of the property.
5. **No parties or events.**
6. **No unregistered guests or visitors allowed.** The maximum property capacity is 5 people, including children.
7. **Quiet time from 10pm - 8am.** Please limit noise levels regardless of the time out of respect for our neighbors.
8. No glass of any kind near the hot tub/spa.
9. No eating or drinking in bedrooms. Please enjoy your meal in the dining room.
10. Please do not rearrange the furniture.

11. Make sure to turn off the lights, air conditioning, and any electronics when you leave the house. Don't forget to close the windows and lock the door.
12. Report any damages and/or breakages in a reasonably timely manner. Damages exceeding the security deposit amount must be paid by guests and will be reported to Airbnb, VRBO, or the applicable booking service.
13. Please place dirty dishes in the dishwasher, dirty towels in the laundry room, and throw out the garbage before checkout. Dispose of the garbage in the trash bins on the East side of the property.
