ORDINANCE NO. 27,676

ORDINANCE AMENDING THE OKLAHOMA CITY MUNICIPAL CODE, 2020, RELATING TO AUTHORIZING CITY EMPLOYEES TO PROVIDE PLUMBING AND MECHANICAL SERVICES AS JOURNEYMEN ON CITY FACILITIES; AMENDING CHAPTER 18 - ELECTRICAL CODE, ARTICLE IV – APPRENTICES, JOURNEYMEN AND CONTRACTORS, BY AMENDING SECTION 18-76 - ELECTRICAL JOURNEYMAN; AND AMENDING CHAPTER 29 - MECHANICAL CODE, ARTICLE IV – APPRENTICES, JOURNEYMEN AND CONTRACTORS, BY AMENDING SECTION 29-76 - MECHANICAL JOURNEYMAN.

ORDINANCE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

SECTION 1. That Section 18-76 of Article IV, of Chapter 18, of the Oklahoma City Municipal Code, 2020, is hereby amended to read as follows:

CHAPTER 18. - ELECTRICAL CODE

* * *

ARTICLE IV. - APPRENTICES, JOURNEYMEN AND CONTRACTORS

* * *

§ 18-76. - Electrical journeyman.

A. An electrical journeyman ~~shall~~, at all times while working, shall have on ~~his/her~~ their person a valid Oklahoma State license in the appropriate categories, and must be in the employment of a person who is licensed and registered under the terms of this Code as an Electrical contractor.

B. Provided, an electrical journeyman while working in the employment of the City may work on municipal utilities/equipment in accordance with Section 1692 of Title 59 of the Oklahoma Statutes, but at all times must have on their person a valid Oklahoma State license in the appropriate categories.

SECTION 2. That Section 29-76, of Article IV of Chapter 29 of the Oklahoma City Municipal Code, 2020, is hereby amended to read as follows:

CHAPTER 29. - MECHANICAL CODE

ARTICLE IV. - APPRENTICES, JOURNEYMEN AND CONTRACTORS

* * *

§ 29-76. - Mechanical journeyman.

A. An Oklahoma State licensed mechanical journeyman ~~shall~~, at all times while working, shall have on ~~his/her~~ their person a valid Oklahoma State license in the appropriate categories, and must be in the employment of a person who is licensed and registered under the terms of this Code as a Mechanical Contractor.

B. Provided, a mechanical journeyman while working in the employment of the City may work on municipal utilities/equipment in accordance with Section 1850.10 of Title 59 of the Oklahoma Statutes, but at all times must have on their person a valid Oklahoma State license in the appropriate categories.
