XII. Comments from Council

Councilmember Stonecipher mentioned Councilmember Nice was elected to office in November 2018 and reelected in 2021 without opposition; so, he had the privilege of sitting next to her for almost six years. He shared that he and Councilmember Nice first met through his friend Jason Ledlow at Stella Nova Coffee on North Western Avenue, where they discussed campaigning and things she could expect to do on the City Council. He said they had a nice visit; he thought she was a little shy and quiet, but he was wrong. He noted that she always articulated her position well, even though they did not always agree. He thanked her for her service and hopes she comes back to see us soon.

Councilmember Carter noted that he and Councilmember Nice only talked a handful of times, but he is extremely impressed with her and looks forward to seeing what she does in the Senate.

Councilmember Cooper inquired when the Request for Proposals for the new arena operator would come before the City Council. Assistant City Manager Aubrey McDermid responded that she did not know but would find out.

XII. Councilmember Cooper mentioned he and Councilmember Nice met 10 years ago in August at the Urban League of Greater Oklahoma City on North Martin Luther King Avenue for a discussion about what could be done in Oklahoma City to address what happened in Ferguson, Missouri. He said when it comes to policy and people, she means business and will hold you accountable. He noted he would have never guessed that four years later, she would run for City Council. He stated one of his biggest surprises was when she showed up to support him at his launch party at Tommy Boy's Pub in Uptown District after winning her election in November. He said they have been friends ever since. Councilmember Cooper reminded everyone that the seat she sits in is a testament to overcoming a legacy of discrimination built into law through Senate Bill No. 1. He briefly discussed voting rights and mentioned the accomplishments of Councilmember Nice: getting a grocery store; preserving black spaces like the Lyons-Luster Mansion, Brockway Center, and the Jewel Theater; honoring Deep Deuce in its black roots; securing \$100 million in MAPS 4 funds for northeast Oklahoma City; stewarding the Willa D. Johnson Recreation Center; and ensuring senior voices were heard for the Senior Wellness Center, guiding it to 950 members from December to February. He stated this is the first time that two black people have served on the City Council together, and it must not be the last. He said while Senate Bill No. 1 is in the history books, Councilmember Nice will also be in the Oklahoma Senate. He wished her Godspeed and expressed gratitude for being his friend. He also thanked her mom for being a friend to his mother.

Councilmember Peck expressed that she spoke to Councilmember Nice directly this morning. She wished her good luck in the Oklahoma State Senate.

Councilmember Peck reminded everyone that today is election day. She said regardless of the outcome for any seat, we will remain united in Oklahoma City. She looks forward to what tomorrow will bring.

Councilmember Stone mentioned he visited a couple of areas in Ward 4 with devastation from tornadoes over the weekend. He asked anyone who was interested in helping with supplies to drop them off at Winwood Free Will Baptist Church, on SE 89th Street, just west of Sooner Road. He said there were a lot of people out there doing great work in providing supplies and support to help them overcome their challenges. He noted that they are in special need of baby supplies, such as diapers, wipes, bottles, and so on. He said he will continue to follow up with City staff to ensure we are doing everything we can to assist. He said as detrimental as this has been, it is a blessing that we have not had any casualties.

Councilmember Stone announced today is his anniversary and congratulated his wife, Mariann on 41 years of marriage.

Assistant City Manager Aubrey McDermid thanked Councilmember Nice on behalf of the City Manager's Office for her service. She mentioned one of her favorite projects for Councilmember Nice was developing a new ordinance prohibiting people from gutting their home, turning off the HVAC system, and operating a commercial Japanese quail-raising facility inside the home, creating a nuisance in the neighborhood. She stated that no response or project was too big or too small for her. She expressed her gratitude for having worked with her and congratulated and wished her the best in the Oklahoma State Senate.

Councilmember Hinkle thanked the Penn South Neighborhood for inviting him to their Neighbors Night Out event; it was a good turnout.

Councilmember Hinkle jokingly expressed his condolences to Mariann Stone on her 41 years of marriage with Councilmember Stone. He said "bless her heart."

XII. Councilmember Hinkle wished Councilmember Nice the best in the Oklahoma State Senate.

Councilmember Hamon mentioned she first met Councilmember Nice sometime between November, after she won her election, and February. She stated that they bumped into one another on Main Street, just outside of Clarity Coffee, where Councilmember Nice was unloading a bus full of older adults who were attending a MAPS 3 meeting to express their views on the Senior Wellness Center in Ward 7. She said this represented Councilmember Nice's service to the city and community very well, particularly in the words of Shirley Chisholm: "If they don't give you a seat at the table, bring a folding chair." She stated that she made a lot of folks bring out folding chairs, and rightfully so, to make space for more voices, people, and perspectives. She commented that it has been an honor serving alongside her, and she encouraged her to continue doing amazing things in the Oklahoma Senate and showing up for the community. She looks forward to working with her.

Municipal Counselor Kenneth Jordan expressed that he greatly enjoyed working with Councilmember Nice over the years. He stated that she has contacted him or his office about many issues that she was very passionate about and worked hard for. He said out of all the councilmembers he has worked with over the years, she was one of the most active for her ward. Ward 7 has been well served.

Councilmember Nice expressed gratitude to her mother, friends, and family for their support. She stated that this has been a journey for everyone on the City Council to understand her, as well as the difficulties, opportunities, and strengths in Ward 7. She noted that some may have appeared unconceivable, unrecognizable, or impossible, but with your support, we have accomplished many good things in Ward 7, for which she is grateful. She thanked and expressed her personal sentiments to the Mayor, Councilmembers, City staff, retired employees Randy Bennett and Beverly Asberry, janitorial staff, cadets, police officers, and her Ward 7 constituents. She said it has been an honor to serve; she is grateful for the next journey, and looks forward to continuing advocacy for Oklahoma City, the relationships, and ensuring that the community is cared for.

Councilmember Nice commented that the victims impacted by the tornadoes over the weekend will remain at the forefront of her mind, and she thanked those who provided support to our Oklahoma City residents. She encouraged everyone to continue those efforts.

Councilmember Nice acknowledged the recent loss of Pastor Kenneth Sherrill, Bishop Lester Cezar, and Bishop Donald Woody, Sr., in addition to Bishop Alonzo Ponder, Jr., Reverend J. A. Reed, Jr., and others who passed before them. She noted that it has been difficult for the black community to experience the loss of our pastors and/or leadership in service during this moment, but we know there is a plan for our community.
