Revocable Permit with the Riversport Foundation for “Riversport Challenge – a TRI-OKC Triathlon,” September 9, 2023, the Boathouse District, and North Oklahoma River Trail, revenue of \$1,375. Wards 6 and 7.

### **Location:**

North Oklahoma River Trail

### **Background:**

Riversport Foundation (Permittee) desires a Revocable Permit (Permit) to hold “Riversport Challenge – a TRI-OKC Triathlon” (Event), as described above. Permittee will, at its expense, plan, organize, and manage the Event.

The Permit will be effective when approved by the City. It will authorize Permittee to use Oklahoma City Riverfront Redevelopment Authority (OCRRA) property, specifically the North Oklahoma River Trail, portion of the Event Site from 6:00 a.m. until 7:00 p.m. on Saturday, September 9, 2023.

This Permit shall authorize Permittee to use public rights-of-way to establish a **Cycling Course**, temporarily closing **Riversport Drive** from South Phillips Avenue west to South Lincoln Boulevard; **South Lincoln Boulevard** from Riversport Drive south to South Central Avenue; **South Central Avenue** from South Lincoln Boulevard south to Southeast 17th Street; **Southeast 17th Street** from South Central Avenue west to South Robinson Avenue; **South Robinson Avenue** from Southeast 17th Street north to Southwest 15th Street; **Southwest 15th Street** from South Robinson Avenue west to South Harvey Avenue; **South Harvey Avenue** from Southwest 15th Street north to Southwest 10th Street; **Southwest 10th Street** from South Harvey Avenue west to South Walker Avenue; **South Walker Avenue** from Southwest 10th Street north to Reno Avenue; **Reno Avenue** from South Walker Avenue east to South EK Gaylord Boulevard; **South EK Gaylord Boulevard** from Reno Avenue south to Oklahoma City Boulevard; **Oklahoma City Boulevard** from South EK Gaylord Boulevard east to South Lincoln Boulevard; **South Lincoln Boulevard** from Oklahoma City Boulevard southwest to Riversport Drive.

Permittee must provide required insurance and indemnification; protect City property; and comply with applicable laws, rules, and regulations. As consideration, Permittee will pay OCRRA \$1,300 and pay the City \$75. OCRRA is scheduled to receive the Permit on August 29, 2023.

**Revenue:**

\$1,300 to be deposited in OCRRA – OCRRA UNASN – OCRRA Special Event Revenue (200 – 0875 – 42050005)

\$75 to be deposited in the General Fund – General Operations – Parks – Special Events (001 – 0001 – 42050011)
