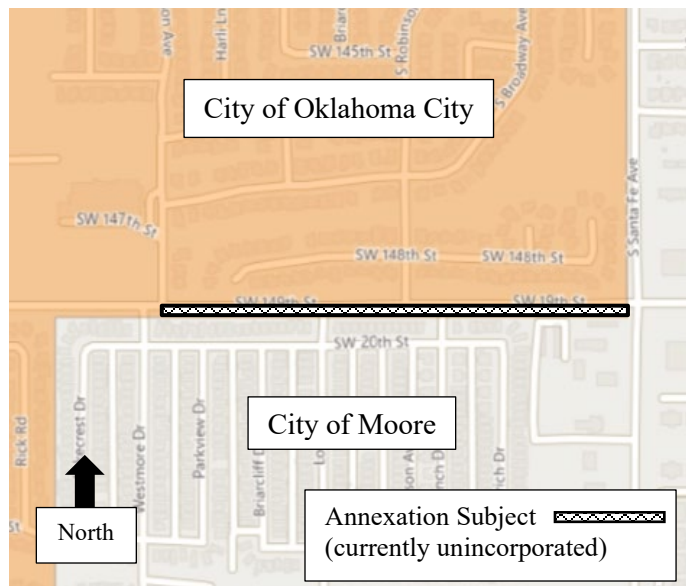

NOTICE IS HEREBY GIVEN that a public hearing will be held by the City Council of the City of Oklahoma City on the **24th day of October 2023, 8:30 a.m. or as soon thereafter as the matter is taken up, in the Council Chambers, 3rd Floor, Municipal Building, 200 North Walker Avenue, Oklahoma City, Oklahoma.**

At which time and place will be heard and considered an ordinance relating to annexation, adding a tract of land being a part of the Northeast Quarter of Section 28, Township 10 North, Range 3 West of the Indian Meridian, Cleveland County, Oklahoma, said tract further described as follows:

Commencing at the Northwest corner of said Northeast Quarter Thence N 89°30'09" E along the North line of said Northeast Quarter a distance of 545.37 Feet to the Point of Beginning; Thence continuing along said North line N 89°30'09" E a distance of 2114.48 Feet to the Northeast corner of said Northeast Quarter; Thence S 00°12'40" E along the East line of said Northeast Quarter a distance of 50.00 Feet; Thence S 89°30'09" W a distance of 2114.48 Feet; Thence N 00°12'40" W a distance of 50.00 Feet to the Point of Beginning.
