

1. General: All material is guaranteed to be as specified. All work to be completed in a workman like manner according to standard practices. All elements of this agreement are contingent upon strikes, accidents, or delays beyond our control.

2. Change Orders: Any alterations or deviations from the above specifications involving extra costs will be done only upon a written change order or verbal agreement. The costs will become an extra charge over and above this estimate. The estimate does not include material price increases, or additional labor and material which may be required should unforeseen problems arise after the work has started. Owners to carry fire, tornado and other necessary insurance. Our workers are fully covered by Workman's Compensation Insurance

3A. Product Warranty: Irrigation installation and repairs shall be guaranteed for 365 days from date of installation. Segmental block retaining walls shall be guaranteed for a period of 180 days from the date of installation. Shrubs, Trees, Perennials and Groundcovers shall be guaranteed for a period of 365 days from date of installation. Annuals shall be guaranteed for a period of 30 day from date of installation. Water Feature Pumps shall be guaranteed for a period of 60 days, unless manufacturer has an extended warranty. All warranty periods are subject to the product warranty disclaimer terms below.

3B. Product Warranty Disclaimer: Invoice must be paid at the time of completion of the project. No warranty repairs will be made until original invoice and any change order are paid in full. Our care instructions must be followed, which consist primarily of watering. Any acts of Nature (i.e. lighting, hail, ice storms, floods, heavy rains, tornado's, earthquakes, etc.) or damage due to accidents (i.e. kids, dogs, cats, rabbits, all domestic and non domestic animals, automobiles, etc.) or vandalism are not covered by this warranty. Warranty becomes void if plants are moved. A suitable substitute shall be allowed if availability becomes impossible. There are no cash refunds, only credits on accounts, no labor. If you over water, under water, or neglect plants warranty is void. Proper irrigation based on seasonal climate factors (temperature, wind, humidity, soil compositions, etc.) must be observed at all times. Extreme shade does not promote quality growth in fescue grass. Traffic must be kept off newly laid sod by people and animals until the grass had been fully rooted and established. Any problems as a result of these issues will not be covered by this warranty. Natural Stone products have color variation. A variation in color shall not constitute a reasonable dispute. All Natural Stone products shall be dictated by trade name. Natural characteristics of stone products, such as efflorescence and cracking shall not constitute a reasonable dispute. Warranty is void, both labor and material, for any damage to work performed by Pitzer's Lawn Management, Inc. that was damaged by another contractor/ party. Owner/GC will be responsible for payment extra charges to repair damage. Pitzer's Lawn Management, Inc. does not warranty existing plants that are transplanted. Replacements shall be performed ONE time only during the warranty period. Any replacement does not carry an additional warranty.

4. Damages: "Private Utilities" that are not able to be located by 1-800 Call OKIE are the responsibility of the Project Owner/GC to locate with marking flags and paint. (i.e: irrigation and pool lines, electrical lines, night lighting wires, drain and gutter lines, parking lot lights, sewer lines, conduits, invisible dog fence or ANY other "private utility" line or service buried below ground). Pitzer's Lawn Management, Inc or its subcontractors will NOT be responsible for repair or restitution of damages to ANY "Private Utility" not located by the Owner/GC. Please note - the Owner/GC saying that private utilities are in the work area, or pointing to the work and saying, " it's buried over there". shall not constitute a proper locate notice. Work shall stop until "Private utilizes" are located as described above. Additional mobilization charges may apply to restart the work.

5. Deposit: Any project costing over \$1000.00 will require a 1/2 deposit with the remainder payable on the day of completion of the project, unless other terms are prearranged.

6. Service Charges: Any Invoice not paid withing 25 days from billing shall bear interest at a rate of 1.5% per month. Additional mobilization charges shall be applied when work is stopped for non-payment of a progressive pay estimate.

7. Lien Notification: In accordance with Oklahoma Law, A notice of Intent to file a lien shall be sent out on any invoice over 45 days old from date of invoice. Liens will be filed prior to an invoice becoming 60 days old from date of invoice.

8. Payment to Vendors: Pitzer's Lawn Management, Inc will not pay project creditors until payment is received from Owner/GC for materials and services rendered. Pitzer's Lawn Management, Inc. will not guarantee liens or claims for services or materials not paid for by the Owner/GC.

It was discovered that the actual tie in points from the fireline paving/cart park areas to the existing golf course cart paths did not match planned elevations. This caused a drastic slope if something was not done. The northern two tie ins were increased to a 5% slope. The southern two tie ins required some engineering to lessen the slope. The determination was made that an 8% slope was too much. In order to reduce the slope to 5% +/- we need to go out 50 feet onto the existing path and demolish and install new path from our paving to those points. This cost is to remove approximately 100lf of existing cart path, grade and reinstall new cart path. Fine grade and sod all disturbed areas. The cost to only go out 25 feet would almost cut the price in half to approx. \$11,250.




