

JOINT RESOLUTION OF THE CITY OF OKLAHOMA CITY AND THE OKLAHOMA CITY PUBLIC PROPERTY AUTHORITY FOR THE OKLAHOMA CITY PUBLIC PROPERTY AUTHORITY TO ASSIGN AND THE CITY OF OKLAHOMA CITY TO ACCEPT COMPETITIVE BIDDING PROCESS FOR PROJECT MP-0560, CIVIC CENTER MUSIC HALL EXTERIOR IMPROVEMENTS, AND APPROVING THE AMENDED CONTRACT AND BONDS.

WHEREAS, Project MP-0560, Civic Center Music Hall Exterior Improvements, is a General Obligation Bond project under the 2017 General Bond Authorization, Proposition 7; and

WHEREAS, Project MP-0560 was advertised and bid by the Oklahoma City Public Property Authority (“OCPPA”) in accordance with the Oklahoma Competitive Bidding Act, and which also complies with the Oklahoma City bidding process; and

WHEREAS, Wynn Construction Co, Inc. was the lowest and best responsible bidder for Project MP-0560 and Alternates 1, 2, 3, and 4 and Unit Prices with a bid of \$1,560,700; and

WHEREAS, award of Project MP-0560 would include both Oklahoma City General Obligation Bond funds and Oklahoma City Public Property Authority Funds; and

WHEREAS, to award Project MP-0560 with Oklahoma City General Obligation Bond funds and OCPPA funds, the OCPPA would need assign and Oklahoma City would need accept the OCPPA bidding process and a Joint Contract between the Oklahoma City Public Property Authority, The City of Oklahoma City and Wynn Construction Co, Inc would be needed for the construction of Project MP-0560.

NOW, THEREFORE BE IT JOINTLY RESOLVED by The City of Oklahoma City and the Oklahoma City Public Property Authority for the Oklahoma City Public Property Authority to assign and the City of Oklahoma City to accept competitive bidding process for Project MP-0560 Civic Center Music Hall Exterior Improvements,

BE IT FURTHER JOINTLY RESOLVED by The City of Oklahoma City and the Oklahoma City Public Property Authority to jointly approve the amended contract and bonds.
