**AN ORDINANCE RELATING TO ZONING AND PLANNING CODE, AMENDING CHAPTER 59 OF THE OKLAHOMA CITY MUNICIPAL CODE, 2020, AMENDING ARTICLE VII - SPECIAL PURPOSE DISTRICTS, BY AMENDING SECTION 59-7200 - DOWNTOWN DESIGN DISTRICTS, TO UPDATE LANGUAGE REGARDING SIGNAGE IN THE AREA AROUND THE OKLAHOMA CITY NATIONAL MEMORIAL; AND DECLARING AN EMERGENCY.**

**EMERGENCY ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OKLAHOMA CITY:**

**SECTION 1:** That Chapter 59, Article VII, Section 59-7200 of the Oklahoma City Municipal Code, 2020, is hereby amended to read as follows:

In order to respect the dignity of the Oklahoma City National Memorial, Off-Premise ~~sSigns/Billboards~~, Electronic Message Display (EMD) signs, ~~Temporary Signs~~ ~~Large Display Banners~~ and Supergraphics (Wallsapes/Building Wraps/~~Large Display Banners~~), ~~and~~ Projection Image Signs, Murals, and Temporary Signs in Certain Public Rights-of-Way (see 59-16113) shall not be permitted in an area of the DBD district located between Dean A McGee Avenue, NW 7th Street, North Broadway Avenue and North Hudson Avenue.
