

RESOLUTION

RESOLUTION OF THE CITY OF OKLAHOMA CITY EXTENDING TIME TO AWARD CONTRACTS AND AWARDING CONTRACTS TO ARROYOS CONCRETE LLC, UPSR-0001-A; EMC SERVICES LLC, UPSR-0001-B; AND RUDY CONSTRUCTION CO., UPSR-0001-C AS LOWEST AND BEST RESPONSIBLE BIDDERS, STREET REPAIRS, CITY WIDE, NOT TO EXCEED \$2,000,000 PER CONTRACTOR; AND APPROVING CONTRACTS AND BONDS.

WHEREAS, the Public Works Director has determined Arroyos Concrete LLC, UPSR-0001-A; EMC Services LLC, UPSR-0001-B; and Rudy Construction Co., UPSR-0001-C were the lowest and best responsible bidders, Street Repairs, City Wide; and

WHEREAS, provisions of the Oklahoma State law known as the Public Competitive Bidding Act of 1974, provides a contracts for construction of a public improvement be awarded within 30 days or within 45 days for good cause shown or within 120 days upon mutual agreement between the lowest responsible bidders and the awarding public agency or agencies; and

WHEREAS, bids were received on March 5, 2025, and due to the time required to receive executed contracts, bonds, bid packet, and the time necessary to route documentation to City Council for approval, contracts award were thereby delayed, preventing award within 30 days of receipt of bids; and

WHEREAS, a letter agreeing to honor the bid for 45 days has been received from Arroyos Concrete LLC, UPSR-0001-A; EMC Services LLC, UPSR-0001-B; and Rudy Construction Co., UPSR-0001-C; and

WHEREAS, it is the desire of the Public Works Department to award the contracts to Arroyos Concrete LLC, UPSR-0001-A; EMC Services LLC, UPSR-0001-B; and Rudy Construction Co., UPSR-0001-C as the lowest and best responsible bidders in the amount not to exceed \$2,000,000 per contractor.

NOW, THEREFORE, BE IT RESOLVED by the Awarding Public Agency that they do hereby extend time to award, and award contracts to Arroyos Concrete LLC, UPSR-0001-A; EMC Services LLC, UPSR-0001-B; and Rudy Construction Co., UPSR-0001-C as the lowest and best responsible bidders, Street Repairs, City Wide, not to exceed \$2,000,000 per contractor; and approving contracts and bonds.
