**REVOCABLE PERMIT
RIGHT-OF-WAY USE**

This Revocable Right-of-Way Use Permit is made and entered into by **The City of Oklahoma City**, a municipal corporation acting by and through its **Mayor and City Council**, hereinafter called “City,” and the **Redbud Foundation**, hereinafter called “Permittee.”

WHEREAS, Permittee desires to hold the “**Redbud Classic**,” an athletic event consisting of 10, 30 and 50 mile bicycle tours and a 10K running course, hereinafter called “Event” on **Saturday, April 6, 2024, and Sunday, April 7, 2024**, using public property and rights-of-way (included streets in **bold**), to establish the bicycling courses on **Saturday, April 6, 2024, exclusively closing NW 63 Street** from North Pennsylvania east to NW Grand Boulevard and **intermittently controlling traffic on NW/NE 63 Street** from NW Grand Boulevard east to North Martin Luther King Boulevard, **North Martin Luther King Boulevard/North Eastern Avenue** from NE 63 Street north to East Britton Road, **East Britton Road** from North Eastern Avenue east to North Triple X Road (**rights-of-way within the municipality of Jones**), **North Sooner Road** from East Britton Road north to East Hefner Road, **East Hefner Road/NE 108 Street** from North Sooner Road east to North Anderson Road (**rights-of-way within the municipality of Jones excluded**), **North Post Road** from East Britton Road north to East Hefner Road, **North Westminster Road** from East Hefner Road south to East Britton Road, **Hogback Road** from East Britton Road north to NE 150 Street, **NE 150 Street** from Hogback Road east to Triple X Road (**rights-of-way within the municipality of Jones excluded**) and **Triple X Road** from NE 150

Street south to East Britton Road; to establish a 10K running course on **Sunday, April 7, 2024, intermittently controlling traffic on Elmhurst Drive** from Dorset Drive west to Greystone Avenue (**rights-of-way within the municipality of Nichols Hills excluded**), **West Wilshire Boulevard** from Dorset Drive west to Greystone Avenue and **Greystone Avenue** from West Wilshire Drive north to Elmhurst Drive.

The above-described area is set out graphically on “**Exhibit A**”. This exhibit is attached hereon and incorporated herein by reference and hereinafter referred to as the “**Event Site Plan**”, and

WHEREAS, it is in the interest of the citizens of the City of Oklahoma City that high-quality cultural activities be maintained and offered to the public; and

WHEREAS, Permittee has established criteria to control the quantity of activities on the public way; and

WHEREAS, the City is willing to grant a revocable permit for use of the public right-of-way in connection with holding the Event.

NOW, THEREFORE, to facilitate and encourage the public enjoyment of the Event and ensure its high quality, and in consideration of the covenants and agreements hereinafter set forth, it is mutually agreed by the parties hereto as follows:

1. City hereby grants Permittee a revocable permit for use of the public right-of-way, hereinafter called the “Permit,” for the purpose of erecting, installing and operating the Event within the public ways and rights-of-way as described above.

2. This Permit shall be effective **7:00 a.m. on Saturday, April 6, 2024, to 12:00 p.m. on Saturday, April 6, 2024,** and at **12:01 p.m. on Saturday, April 6, 2024,** the rights under this Permit to utilize the Event Site shall fully terminate.
3. This Permit shall be effective from **12:00 p.m. on Sunday, April 7, 2024, to 3:30 p.m. on Sunday, April 7, 2024,** and at **3:31 p.m. on Sunday, April 7, 2024,** the rights under this Permit to utilize the Event Side shall fully terminate.
4. During the time period described in Section 2, Permittee will be authorized to limit motorized-vehicle access to the Event Site by the placement of required traffic control devices, volunteers and Oklahoma City Police personnel as illustrated on **“Exhibit B”**. This exhibit is attached hereon and incorporated herein by reference and hereinafter referred to as the **“Traffic Control Plan”**.
5. The Permittee agrees to assume full responsibility for cleanup and control of trash, debris, waste water and all waste generated or otherwise occurring within the Event Site as result of the Event. The plans for control and cleanup of all types of Event generated waste are shown on **“Exhibit C”**. This exhibit is attached hereon and incorporated herein by reference as the **“Waste Plan”**.
6. Residents and businesses abutting the Event Site will be notified by the Permittee according to the approved guidelines for notification provided in the current edition of the [Oklahoma City Special Events Guide](#).
7. It is understood that it is in the public interest that the activities for the Event be limited to such a number and otherwise regulated by the Permittee so as to insure

- the public health, safety and welfare during the Event and to maintain high standards of quality for the use and benefit of the citizens of Oklahoma City.
7. This permit shall be subject to the definitions and regulations established for Outdoor Special Events in [Chapter 50, Article VIII, Sections 261-265 of the Oklahoma City Municipal Code](#).
 8. This permit shall be subject to all applicable fees established in the General Schedule of Fees for Outdoor Special Event Permits in [Chapter 60, Article VIII, Section 60-50-56 of the Oklahoma City Municipal Code](#).
 9. The Event shall be subject to all applicable guidelines established in the current edition of the [Oklahoma City Special Events Guide](#).
 10. This permit shall be revocable at will by either party subject to the terms established for revocation in [Chapter 50, Article VIII, Section 266 of the Oklahoma City Municipal Code](#).
