**ORDINANCE ESTABLISHING RESERVED PARKING SPACES FOR
THE PHYSICALLY DISABLED ON WEST MAIN STREET AT THE

APPROXIMATELY 318 FEET EAST TO 345 FEET EAST OF THE

- 2. ON THE NORTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 218 FEET EAST TO 245 FEET EAST OF THE
EAST CURB LINE OF NORTH PENNSYLVANIA AVENUE;**
- 3. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 56 FEET EAST TO 83 FEET EAST OF THE EAST
CURB LINE OF NORTH VIRGINIA AVENUE;**
- 4. ON THE NORTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 183 FEET EAST TO 210 FEET EAST OF THE
EAST CURB LINE OF NORTH VIRGINIA AVENUE;**
- 5. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 38 FEET WEST TO 65 FEET WEST OF THE WEST
CURB LINE OF NORTH KENTUCKY AVENUE;**
- 6. ON THE NORTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 36 FEET EAST TO 61 FEET EAST OF THE EAST
CURB LINE OF NORTH KENTUCKY AVENUE;**
- 7. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 59 FEET WEST TO 118 FEET WEST OF THE
WEST CURB LINE OF NORTH INDIANA AVENUE;**
- 8. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 53 FEET WEST TO 80 FEET WEST OF THE WEST
CURB LINE OF NORTH BLACKWELDER AVENUE;**
- 9. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 42 FEET EAST TO 69 FEET EAST OF THE WEST
CURB LINE OF NORTH BLACKWELDER AVENUE;**
- 10. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 31 FEET WEST TO 58 FEET WEST OF THE WEST
CURB LINE OF NORTH MCKINLEY AVENUE;**
- 11. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 30 FEET WEST TO 57 FEET WEST OF THE WEST
CURB LINE OF NORTH DOUGLAS AVENUE; AND**
- 12. ON THE SOUTH SIDE OF WEST MAIN STREET FROM
APPROXIMATELY 32 FEET EAST TO 59 FEET EAST OF THE EAST
CURB LINE OF NORTH DOUGLAS AVENUE.**

ORDINANCE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

SECTION 1. Reserved Parking. Reserved parking spaces for the physically disabled on West Main Street shall be established.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
