Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel not to appeal and to comply with the Order of the Workers' Compensation Commission Claim No. CM3-2023-02649A, styled: *Laura Shoemake, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and authorizing the Municipal Counselor to assist said counsel in the rendition of the Order to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, Laura Shoemake is 60 years old and a 19-year employee of The City of Oklahoma City. At the time of the injury she was assigned to the Utilities Department as an Administrative Coordinator and continues to be employed by the City.

The Claimant sustained an undisputed accidental injury on April 5, 2023 to her left wrist. The Claimant required surgery to her left wrist on May 4, 2023.

The Claimant was evaluated by Dr. Lance Rosson on behalf of her attorney and found to have the following permanent partial impairment: left wrist 39%. The Claimant was also evaluated by Dr. Calvin Johnson on behalf of the City and found to have the following permanent partial impairment: left wrist 2%. On November 8, 2024, Judge Tara Inhofe, of the Workers' Compensation Commission, awarded Claimant the following permanent partial disability: left wrist 18%, entitling Claimant to 39.60 weeks of compensation at \$360 per week, totaling \$14,256. As of November 8, 2024, the amount of said award was fully accrued at \$14,256.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$427.68 be deducted and paid for the Multiple Injury Trust Fund Tax, making the lump sum award \$13,828.32. The Court further ordered \$2,851.20 or 20% of the PPD award be deducted from the award and paid in a lump sum to Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational Health and Safety Tax Fund, representing .75% of the permanent partial disability award in the sum of \$106.92 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award in the sum of \$285.12.
