

RESOLUTION

RESOLUTION OF THE CITY OF OKLAHOMA CITY ESTABLISHING RENTAL AND ADMISSION FEES AS SET FORTH IN EXHIBIT “A” FOR PARK FACILITIES AND AMENITIES WHICH ARE LOCATED IN PUBLIC PARKS OPERATED BY THE PARKS AND RECREATION DEPARTMENT

WHEREAS, The City of Oklahoma City (“City”) is a charter city established in accordance with Article XVIII of the Oklahoma Constitution; and

WHEREAS, the City provides a variety of parks and recreational venues and services for the use and enjoyment of the public; and

WHEREAS, the City’s Parks and Recreation Department (“OKC Parks”) operates over 170 public parks owned by the City; and

WHEREAS, the mission of OKC Parks is to provide cultural, social, and recreational experiences to our community so they can have the opportunity to cultivate wellness and enjoy a healthy lifestyle; and

WHEREAS, Section 38-104(b) of the Oklahoma City Municipal Code, 2020, authorizes the City Council to establish fees for the use of property, equipment, and services of OKC Parks; and

WHEREAS, the public parks operated by OKC Parks contain numerous recreational facilities, such as swimming pools, event centers, pavilions, community centers, gymnasiums, athletic fields, tennis courts, amphitheaters, etc.; and

WHEREAS, in order to provide high-quality recreational experiences for the community, it is necessary for OKC Parks to charge rental and admission fees for park facilities and amenities; and

WHEREAS, City staff believe this process will allow OKC Parks to respond more efficiently to changing market conditions and customer demands; and

WHEREAS, the City Council desires to establish rental and admission fees for park facilities and amenities, including fees for the equipment and services connected with their use, as set forth in Exhibit “A” to this Resolution; and

WHEREAS, patrons of OKC Parks facilities must comply with City ordinances and Parks Department policies; and

WHEREAS, fees for event permits for the use of general park property will continue to be established in Chapter 60, the General Schedule of Fees; and


WHEREAS, any changes to this Resolution and/or Exhibit “A” will need to be recommended by the Park Commission and approved by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City to hereby establish rental and admission fees as set forth in Exhibit “A” for park facilities and amenities which are located in public parks operated by the Parks and Recreation Department.





RENTAL AND ADMISSION FEES FOR PARK FACILITIES AND AMENITIES **OPERATED BY OKC PARKS**

Swimming Pool Admissions:

Community Pools (Northeast Park Pool, Woodson Park Pool)

Per visit

Youth (3-17) and Senior (55+): Free

Adult (18-54): \$2.00

Unlimited monthly swimming (Adult 18-54): \$15.00

Family Aquatic Centers (Earlywine Park and Will Rogers Park)

Per visit

Youth (3-17): \$5.00

Adult (18-54): \$6.00

Senior (55+): \$5.00

Non-swimmer Admission: \$4.00

Season Passes

Individual pass: \$45.00

Family/Group pass for four: \$150.00

Each additional family/group member: \$35.00

\$225.00 per hour, two hours minimum, and includes 2 lifeguards for up to 100 people; 30-day advance reservation required

\$375.00 per hour, two hours minimum, 30-day advance notice required, subject to Director's approval, which includes six (6) lifeguards (300 people and under)

\$20.00 per additional lifeguard per hour, based on attendance above 300 people
