**AMENDMENT TO THE YOUTH HOMELESSNESS DEMONSTRATION
PROGRAM GRANT AGREEMENT**

This Amendment to Grant Agreement is made by and between the United States Department of Housing and Urban Development (HUD) and City of Oklahoma City (the recipient), of 420 West Main, Suite 920, Oklahoma City, OK 73102.

RECITALS

1. HUD and the Recipient entered into a Grant Agreement dated 09/23/2022 having Grant No. — OK0185Y6I021900 (the Grant Agreement) which expires on 11/30/2024.
2. The parties are desirous of correcting the period of performance start and end dates for the project, which were incorrectly entered on the Scope of Work, to the Grant Agreement.
3. At the expiration of the Grant Agreement, the Recipient expects to have unspent funds remaining in its grant account. HUD and the Recipient are desirous of allowing the Recipient to retain those funds and to continue to use them for eligible project expenditures.
4. The need for assistance provided by the project continues to exist within the jurisdiction where the project is located.
5. HUD has determined that the grant funding remaining at the end of the grant term should not be deobligated.
6. The term of the Grant Agreement is HUD-approved to extend through December 31, 2024.
7. The parties are desirous of amending the Grant Agreement to shift more than 10% from one eligible activity to another for OK0185Y6I021900 to increase the number of units.
8. HUD has determined that the change is necessary to better serve eligible persons within the geographic area and to ensure that the priorities established under the FY2019/FY2020 Youth Homelessness Demonstration Program Notice of Funding Opportunity are met.


