

## RESOLUTION

**RESOLUTION AUTHORIZING THE MUNICIPAL COUNSELOR TO CONFESS JUDGMENT WITHOUT ADMITTING LIABILITY IN THE CASE OF *BIG TOP ENTERTAINMENT, LLC, D/B/A DOLLHOUSE LOUNGE, MISTY KOKOJAN, INDIVIDUALLY, AND AS OWNER OF BIG TOP ENTERTAINMENT, LLC D/B/A DOLLHOUSE LOUNGE, JERRY E. JOHNSON, ANNAH LEDESMA, KARLY NEUMANN, MARGARET SHUART, ABIGIAL WHISMAN, LAUREN FARRIS, AND LUIS VARGAS V. THE CITY OF OKLAHOMA CITY*, IN THE OKLAHOMA COUNTY DISTRICT COURT CASE NO. CJ-2023-656.**

**WHEREAS**, the lawsuit styled *Big Top Entertainment, LLC, d/b/a Dollhouse Lounge, Misty Kokojan Individually and as Owner of Big Top Entertainment, LLC, d/b/a Dollhouse Lounge, Jerry E. Johnson, Annah Ledesma, Karly Neumann, Margaret Shuart, Abigail Whisman, Lauren Farris and Luis Vargas, v. The City of Oklahoma City* has been filed in the District Court for Oklahoma County, State of Oklahoma;

**WHEREAS**, the City Council has determined that a settlement of Two Hundred and Eighty Thousand Dollars (\$280,000) is a just and reasonable settlement of said case, with Eighty Thousand Dollars (\$80,000) allocated to settle the claims of Jerry Johnson, Karly Neumann, Maragret Shuart, Lauren Farris, and Luis Vargas and Two Hundred Thousand (\$200,000) allocated to settle the claims of Misty Kokojan and Big Top Entertainment, LLC.

**WHEREAS**, it is the desire of the City Council to make such settlement by authorizing the Municipal Counselor to draft the necessary paperwork to settle this case and to prepare and file a Journal Entry of Judgment, which does not admit liability in said case.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF OKLAHOMA CITY** that the Municipal Counselor be, and he is hereby directed to prepare and file all necessary paperwork to effectuate this settlement, including a Journal Entry of Judgment confessing Judgement without admitting liability.
