Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2023-0038305 styled: *Linda Kaszowski, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### Background:

The Claimant, Linda Kaszowski is 58 years old and a 32- year employee of The City of Oklahoma City. At the time of the injury she was assigned to the Municipal Counselor's Office as a Legal Administrative Specialist and continues to be employed by the City.

Claimant sustained an undisputed accidental injury on November 13, 2023 to her right elbow and left elbow. The Claimant required surgery to her right elbow on March 11, 2024 and to her left elbow April 4, 2024.

Claimant was evaluated by Dr. Daron Hitt, on behalf of the City and found to have the following permanent partial impairment: right elbow 4%, left elbow 4%. The negotiated Joint Petition Settlement calls for a PPD award of \$13,860 for the following permanent partial disability: right elbow 7%, left elbow 7%.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$415.80 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award \$13,444.20. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$103.95 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$277.20.
