

RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST RATIFYING THE ACTIONS OF THE GENERAL MANAGER IN DECLARING AN EMERGENCY; APPROVING THE BIDDING DOCUMENTS, AND AWARDING A CONTRACT TO JORDAN CONTRACTORS, INC., PROJECT SE-0056, EMERGENCY SANITARY SEWER LINE REPLACEMENT, NE 4TH STREET BETWEEN KATE AVENUE AND FONSHILL AVENUE, \$316,380; RATIFYING ISSUANCE OF AN EMERGENCY WORK ORDER; AND APPROVING THE CONTRACT AND BONDS.

WHEREAS, the sewer line needs to be replaced due to collapsing; and

WHEREAS, the necessary repairs will include a new sewer main and a manhole rehabilitation; and

WHEREAS, it was in the best interest of the public health, safety, and welfare that repairs be done timely to restore the operational capacity in the area; and

WHEREAS, the General Manager declared an emergency to exist; and

WHEREAS, the emergency contract for Project SE-0056 in the amount of \$316,380 was awarded by the General Manager to Jordan Contractors, Inc.; and

WHEREAS, Jordan Contractors, Inc. has signed the contract and bonds for Project SE-0056 for the bid amount of \$316,380; and

WHEREAS, the City Engineer issued an emergency work order.

NOW, THEREFORE, BE IT RESOLVED by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify the actions of the General Manager in declaring an emergency; approving the bidding documents, and awarding a contract to Jordan Contractors, Inc., Project SE-0056, Emergency Sanitary Sewer Line Replacement, NE 4th Street between Kate Avenue and Fonshill Avenue, \$316,380; and

BE IT FURTHER RESOLVED by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify issuance of an emergency work order; and

BE IT FURTHER RESOLVED by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby approve the contract and bonds.
