Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2023-0026840 styled: *Angela Martin, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, Angela Martin is 65 years old and a 25-year employee of The City of Oklahoma City. At the time of the injury she was assigned to the Police Department as a Unit Operations Leader and continues to be employed by the City.

The Claimant sustained an undisputed accidental injury on September 1, 2022 to her left wrist, left elbow and right ring finger.

The Claimant required surgery to her left wrist and left elbow on September 26, 2023 and to her right ring finger on February 2, 2024.

Claimant was evaluated by Dr. William Jones on behalf of the City and found to have the following permanent partial impairment: left wrist 5%, left elbow 7%, right ring finger 5%. The negotiated Joint Petition Settlement calls for a PPD award of \$21,780 for the following permanent partial disability: left wrist 6%, left elbow 10%, right ring finger 9%.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$653.40 be deducted and paid on behalf of the claimant for the Multiple Injury Trust Fund Tax, making the lump sum award \$21,126.60. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$163.35 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$435.60.
