

RESOLUTION APPROVING ADDENDUM NO. 1, MAPS 4 C.B. CAMERON PARK RAW WATER LINE; EXTENDING TIME TO AWARD THE CONTRACT; AWARDED CONTRACT TO WYNN CONSTRUCTION CO., INC. IN THE AMOUNT OF \$1,430,000; AND APPROVING CONTRACT AND BONDS, PROJECT M4-NPS12.

WHEREAS, on December 10, 2019, the voters of The City of Oklahoma City voted to approve the levy of the Oklahoma City Capital Improvements Sales Tax for the MAPS 4 Program; and

WHEREAS, on February 4, 2020, the City Council established the MAPS 4 Citizens Advisory Board for the purposes of advising the City Council regarding projects proposed for funding from the Oklahoma City Capital Improvements Sales Tax; and

WHEREAS, the MAPS 4 Program includes improvements to the existing soccer facilities at C.B. Cameron Park; and

WHEREAS, this project is the MAPS 4 C.B. Cameron Park Raw Water Line, Project M4-NPS12, which is a new raw waterline to be installed to feed the new irrigation system from Lake Hefner; and

WHEREAS, Addendum No. 1 was issued during bidding to revise the drawing sheets for Project M4-NPS12, MAPS 4 C.B. Cameron Park Raw Water Line; and

WHEREAS, bids were opened on December 20, 2023 for Project M4-NPS12, MAPS 4 C.B. Cameron Park Raw Water Line; and

WHEREAS, provisions of the Public Competitive Bidding Act mandate that a contract for construction be awarded within 30 days of bid opening and within 90 days when funds are furnished by a United States Governmental agency upon mutual written agreement between the lowest responsible bidder and the awarding agency; and

WHEREAS, due to the timing of the receipt of the bids and the MAPS 4 Neighborhoods Subcommittee, MAPS 4 Citizens Advisory Board and City Council meetings, it is necessary to extend the time to award the contract; and

WHEREAS, the lowest and best bidder, Wynn Construction Co., Inc., has agreed to hold the bid prices until the contract is awarded; and

WHEREAS, City staff reviewed the bids and recommend awarding the contract to the lowest and best bidder, Wynn Construction Co., Inc. in an amount of \$1,430,000 for Project M4-NPS12, MAPS 4 C.B. Cameron Park Raw Water Line.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of The City of Oklahoma City to approve Addendum No. 1, Project M4-NPS12, MAPS 4 C.B. Cameron Park Raw Water Line; extend the time to award the contract; approve the contract with Wynn Construction Co., Inc. in an amount of \$1,430,000; and approve the contract and bonds.
