

**AMENDMENT NO. 1  
PROFESSIONAL SERVICES AGREEMENT  
GRAVITEC SYSTEMS, INC. (OCWUT00054)**

This amendment (herein after “Amendment No. 1”) to the Professional Services Agreement (“Agreement”) is made and entered into by and between the Oklahoma City Water Utilities Trust, otherwise referred to as (“OCWUT”), and Gravitec Systems, Inc., herein referred to as the (“Service Provider”), (each a “Party” and collectively referred to as the “Parties”).

**WITNESSETH:**

**WHEREAS**, on May 8, 2024, OCWUT prepared a Request for Proposal (“RFP”) seeking a Professional Services Agreement for qualified Proposers to perform planned inspection, evaluations, design, fabrication, and installation services for areas indicated as fall hazards; and

**WHEREAS**, OCWUT awarded and entered into an Agreement with the Service Provider on September 10, 2024, for professional services related to the services described in the RFP; and

**WHEREAS**, the RFP identified the site locations where the Service Provider would be expected to perform services, and the Agreement includes the Service Provider’s Schedule of Fees for each site location; and

**WHEREAS**, an additional site location for these services has been identified by staff for the Atoka tower which is not otherwise incorporated into the Agreement; and

**WHEREAS**, the Parties agree to amend the Agreement to include the additional site location; and

**WHEREAS**, **Section 10(g) Amendments** of the Agreement authorizes amendments, modifications, alterations, and supplements to be made to the Agreement by separate written agreement executed by both of the Parties; and

**WHEREAS**, staff recommends the approval of Amendment No. 1 to include the additional site location and amend the schedule of fees to include pricing for the additional site location in accordance with the services performed under the Agreement.

**NOW, THEREFORE**, in mutual consideration herein described and other good and valuable consideration, receipt of which is hereby acknowledged, the Parties agree to amend the Agreement as follows:

I. Attachment “C” (Schedule of Fees and Rate Card) is hereby removed in its entirety and replaced by the new Attachment “C” (Schedule of Fees and Rate Card) which is attached to this Amendment No.1.

II. This Amendment No.1 will be effective upon approval of the last party hereto and shall be applicable to those services and fees therefore as rendered.

**FURTHERMORE**, except as modified and amended herein, all other terms and provisions of the Agreement shall remain in full force and effect and are binding on the Parties. In the event of any conflict between the provisions of this Amendment No. 1 and the provisions of the Agreement, the provisions of this Amendment No. 1 will control.
