

## RESOLUTION

### A RESOLUTION OF THE CITY OF OKLAHOMA CITY HISTORIC PRESERVATION COMMISSION RECOMMENDING THE PERRINE BUILDING AS ELIGIBLE FOR LISTING IN THE NATIONAL REGISTER OF HISTORIC PLACES

**WHEREAS**, the Perrine Building is located within the incorporated area of the City of Oklahoma City, at 119 North Robinson Avenue; and

**WHEREAS**, the National Register of Historic Places nomination demonstrates the importance of the Perrine Building to the history and culture of Oklahoma City; and

**WHEREAS**, the Perrine Building is locally significant in the area of History: Ethnic Heritage/Black and Community Planning and Development; and

**WHEREAS**, the Perrine Building is locally significant in the area of Architecture: Commercial and Art Deco Styles; and

**WHEREAS**, the Perrine Building was an important hub for the Civil Rights Movement in Oklahoma City; and

**WHEREAS**, the Perrine Building contained the oldest and longest running cafeteria in Oklahoma City's history, Anna Maude (1928-1988); and

**WHEREAS**, during the early 1960s, the Perrine Building was the site of numerous Civil Rights demonstrations aimed at ending segregation in public accommodations; and

**WHEREAS**, the Perrine Building played a central role as a commercial office tower and retail hub in downtown Oklahoma City throughout its lifespan; and

**WHEREAS**, the Perrine Building is one of the last high-rises built in the 1920's in Oklahoma City's downtown core; and

**WHEREAS**, the Perrine Building National Register of Historic Places nomination, prepared by Isaac Hines, AIA, of Tradesman Architectural Studios, is an accurate and scholarly written document; and

**WHEREAS**, this action is consistent with the provisions of Chapter 59, Section 3300.2 of the Historic Preservation Ordinance contained in the *Zoning and Planning Code; Oklahoma City Municipal Code, (2020)*.


### **NOW, THEREFORE, BE IT RESOLVED BY THE HISTORIC PRESERVATION COMMISSION, THAT:**
