

NOTICE OF HEARING

NOTICE IS HEREBY GIVEN, that an application has been filed to close the following described public way or easement:

A tract of land being a part of the Southeast Quarter (SE/4) of Section Twenty-eight (28) and the Southwest Quarter (SW/4) of Section Twenty-seven (27), Township Twelve (12) North, Range Three (3) West of the Indian Meridian, Oklahoma City, Oklahoma County, Oklahoma and being more particularly described as follows: Commencing at the Northeast (NE) Corner of said Southeast Quarter (SE/4); THENCE South 00°00'27" East, along and with the East line of said Southeast Quarter (SE/4), a distance of 55.03 feet to the North line of the recorded plat ANTON H. CLASSEN'S NORTH BROADWAY ADDITION (PLAT), being the POINT OF BEGINNING; THENCE North 89°42'25" East, along and with the North line of said PLAT, a distance of 27.71 feet to the Northeast (NE) Corner of said PLAT; THENCE South 01°21'44" West, along and with East line of said PLAT, a distance of 976.78 feet; THENCE North 89°46'35" East, continuing along and with said East line, a distance of 28.64 feet to the East 33 foot Statutory right-of-way line of the West line of said SW/4; THENCE South 00°00'27" East, along and with said East 33 foot Statutory right-of-way line, a distance of 247.41 feet to the South line of said PLAT; THENCE South 89°46'35" West, along and with the South line of said Plat, a distance of 66.00 feet to the West 33 foot Statutory right-of-way line of the East line of said SE/4; THENCE North 00°00'27" West, along and with said West 33 foot Statutory right-of-way line, a distance of 1,223.75 feet to the North line of said Plat; THENCE North 89°42'25" East, along and with said North line, a distance of 33.00 feet to the POINT OF BEGINNING.

An ordinance closing the above-described easement was introduced at City Council meeting on November 5, 2024, and a public hearing will be held on December 17, 2024 in the City Council Chamber, Third Floor, 200 North Walker Avenue, Oklahoma City, Oklahoma 73102 beginning at 8:30 a.m.


