1. Renewal No. 1 of pricing agreements, Power Play, LLC (COKC00059) and Sunbelt Pools, Inc. (COKC00060), aquatic facilities, equipment, parts and supplies, estimated cost \$200,000, May 7, 2025 through May 6, 2026; and
2. Resolution authorizing the open market purchase of related items not available on a pricing agreement (COKC00068), estimated cost \$75,000, May 7, 2025 through May 6, 2026.

Purpose:

To renew pricing agreements for the purchase of aquatic facilities, equipment, parts and supplies. The Parks and Recreation Department has a continuous need to purchase equipment, parts, supplies, to maintain, repair, and operate various aquatic facilities consisting of swimming pools, spraygrounds and aquatic displays. The types of supplies purchased will vary, depending on the programs offered, participant interest and Departmental needs.

Background:

These pricing agreements were originally awarded on May 7, 2024 (Item No. IX.D.) for the period ending May 6, 2025. These agreements have two one-year renewal options. This is the first renewal of these agreements.

The pricing agreements meet the City's policy on renewal of pricing agreements for goods and services. Staff have notified the vendors that the City wishes to renew the pricing agreements under the same terms and conditions as previously awarded. A cost adjustment request was received from Sunbelt Pools, Inc. (COKC00060). The request was reviewed by staff, and determined the adjustment aligns with current market conditions. A letter agreeing to the renewal has been received from both vendors.

The estimated cost for these pricing agreements is based on previous expenditures for this commodity. There is no obligation to purchase from the agreements. All purchases are subject to future appropriations and the availability of funds.

Staff requests the open market purchase of aquatic facilities, equipment, parts, supplies and related items not available on a pricing agreement (COKC00068), estimated cost \$75,000, May 7, 2025 through May 6, 2026. Purchases made with this authority will comply with the City's open market purchasing procedures. Individual purchases exceeding \$50,000 under this open market resolution will be approved by the City Council through a separate agreement or resolution.
