Cancellation of Project PJ-OK-0157, Street Improvements, SE 74th Street from Peebly Road to Luther Road; and release of funds be approved. Ward 4.

### **Location:**

SE 74th Street from Peebly Road to Luther Road

### **Background:**

This unlisted project for street improvements was originally an allocation of the 2017 General Obligation Bond Authorization, however, due to shifting resources priorities, the county was unable to allocate the necessary support to complete the project as planned..

Funds in the amount of \$450,000 were approved for use at the above location in June 2021. Construction never began due to a lack of execution of the agreement by The County.

Oklahoma County used their resources for other projects to support the Kickapoo Turnpike and the project is no longer a viable candidate for a partnership. The funds remaining from this project would be better served by a release of the funds to the General Obligation Bond Authorization for reallocation.

Council is requested to approve a cancellation of Project PJ-OK-0157, street improvements, SE 74th Street from Peebly Road to Luther Road, and release the funds.
