

## **RESOLUTION**

A RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY ESTABLISHING A DATE FOR THE PROPOSED ENACTMENT OF AN ORDINANCE CLOSING A PUBLIC WAY OR EASEMENT, DETERMINING THOSE ENTITLED TO NOTICE OF SAME, AND DIRECTING THAT SAID NOTICE BE ISSUED.

WHEREAS, an application to close the following described public way or easement has been considered by the Planning Commission of The City of Oklahoma City as part of a Master Plan or amendment of same, to-wit:

A tract of land being a part of Lot 1, Block 5 as shown on the recorded plat known as Preston Commercial Section III to the City of Oklahoma City, and also being a part of the Northwest Quarter of Section FIFTEEN (15), Township THIRTEEN (13) North, Range FOUR (4) West of the Indian Meridian, Oklahoma County, Oklahoma, being more particularly described as follows: With the basis of bearing being North 89°40'58" East along the South line of said Northwest Quarter (NW/4); Commencing at the Southwest Corner of the Northwest Quarter (NW/4) of said Section FIFTEEN (15); Thence North 89°40'58" East along the South line of said Northwest Quarter (NW/4) a distance of 757.69 feet; Thence North 00°29'18" West a distance of 158.74 feet; Thence South 27°10'31" West a distance of 32.31 feet to the POINT OF BEGINNING; Thence continuing South 27°10'31" West a distance of 96.30 feet; Thence South 86°36'33" West a distance of 9.14 feet; Thence North 36°54'19" West a distance of 7.93 feet; Thence North 27°10'31" East a distance of 126.90 feet; Thence South 00°29'18" East a distance of 32.31 feet to the point of beginning.

WHEREAS, an ordinance closing the same is proposed to be considered by the City Council on the 12TH day of MARCH, 2024; and

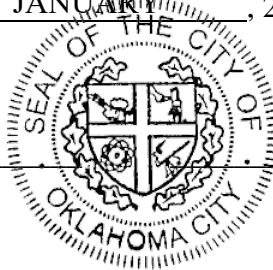
- A. All above listed franchise holders.
