

RESOLUTION AUTHORIZING THE OPEN MARKET PURCHASE OF EMERGENCY VETERINARY SERVICES, INCLUDING SPAY AND NEUTER SERVICES, NO BID ITEMS AND RELATED ITEMS NOT AVAILABLE ON A PRICING AGREEMENT (COKC00892), ESTIMATED COST \$150,000, NOVEMBER 22, 2024 THROUGH NOVEMBER 21, 2025.

WHEREAS, this agreement was originally awarded on November 8, 2022 (Item No. IX. E. 1&2) for the period ended November 21, 2023; and

WHEREAS, this agreement was re-assigned from Safe Haven Human Society to ABC Clinic on September 26, 2023 (Item No. IX. E); and

WHEREAS, this pricing agreement was renewed on November 21, 2023 (Item No. IX. D) for the period ending November 21, 2024; and

WHEREAS, a pricing agreement is being renewed for the period ending November 21, 2025; and

WHEREAS, staff requests Council authorization for the open market purchase of emergency veterinary services, including spay and neuter services no bid items and related items not available on a pricing agreement (COKC00892), estimated cost \$150,000, November 22, 2024 through November 21, 2025; and

WHEREAS, purchases made with this authority will comply with the City's open market purchasing procedures; and

WHEREAS, individual purchases exceeding \$50,000 under this open market resolution will be approved by the City Council through a separate agreement or resolution; and

WHEREAS, there is a continuing need for this commodity.

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that they do hereby authorize the open market purchase of emergency veterinary services, including spay and neuter services, no bid items and related items not available on a pricing agreement (COKC00892), estimated cost \$150,000, November 22, 2024 through November 21, 2025.
